

PRIVACY POLICY

REVEAL GENOMICS, S.L. informs you about its Privacy Policy regarding the treatment and protection of personal data of users that may be collected by browsing or contracting services through the website www.reveal-genomics.com. In this regard, the Owner guarantees compliance with current regulations on personal data protection, contained in the Organic Law 3/2018, December 5th, on the Protection of Personal Data and Guarantee of Digital Rights (LOPD GDD). It also complies with Regulation (EU) 2016/679 of the European Parliament and Council of 27 April 2016 on the protection of individuals (RGPD). The use of this website implies the acceptance of this Privacy Policy as well as the conditions included in the Legal Notice. Principles applied in data processing: In the processing of your personal data, the Holder will apply the following principles which are in accordance with the requirements of the new European data protection regulation:- Principle of legality, loyalty and transparency: The Holder will always require consent for the processing of your personal data which may be for one or more specific purposes about which he will inform you in advance with absolute transparency.- Principle of data minimization: The Holder will only ask you for the data strictly necessary for the purpose or purposes for which it is requested.- Principle of limitation of conservation period: The data will be kept for the time strictly necessary for the purpose or purposes of treatment. The Holder will inform you about the corresponding conservation period according to the purpose. In the case of subscriptions, the Holder will periodically review the lists and remove those records that have been inactive for a considerable time.- Principle of integrity and confidentiality: Your data will be treated in such a way that its security, confidentiality and integrity is guaranteed. You should know that the Holder takes the necessary precautions to prevent unauthorized access or misuse of their users' data by third parties.

Obtaining personal data: In order to navigate through www.reveal-genomics.com it is not necessary to provide any personal information. The cases in which you do provide your personal data are the following:- When contacting through the contact forms or sending an email.- When you sign up for a subscription form or a newsletter that the Holder manages with Moosend.

Your rights: The Holder informs you that regarding your personal data, you have the right to:- Request access to stored data.- Request a rectification, erasure or cancellation.- Request the limitation of its treatment.- Oppose to the treatment.- Request the portability of your data. The exercise of these rights is personal and therefore must be exercised directly by the interested party, requesting it directly to the Holder, which means that any customer, subscriber or collaborator who has provided their data at any time may contact the Holder and ask for information about the data they have stored and how they were obtained, request the rectification of the same, request the portability of their personal data, oppose the treatment, limit its use or request the cancellation of these data in the files of the Holder. To exercise your rights of access, rectification, cancellation, portability, and opposition you must send an email to info@reveal-genomics.com together with the proof valid in law as a copy of your ID card or equivalent. You have the right to effective judicial protection and to file a complaint with the control authority, in this case, the Spanish Data

Protection Agency, if you consider that the processing of personal data concerning you violates the Regulations.

Purpose of the processing of personal data: When you connect to the website to send an email to the Holder, subscribe to their newsletter or make a recruitment, you are providing personal information for which the Holder is responsible. This information may include personal data such as your IP address, first and last name, physical address, email address, phone number, and other information. Registration for HER2DX ordering: Name and surname, email address, telephone number, collegiate number and hospital or clinic where you provide your services; identification data of your patient. The purpose of this treatment is the request of the HER2DX test services for those patients who signed the informed consent to have done the test. This treatment will include the transfer of medical data, samples and tissues essential for carrying out the test.

There are other purposes for which the Holder treats your personal data:- To ensure compliance with the conditions contained in the Legal Notice and applicable law. This may include the development of tools and algorithms that help this website to ensure the confidentiality of personal data it collects.- To support and improve the services offered by this website.- To analyze the navigation.
